GENERAL CONDITIONS

- 1) It is requested that mares should be sent UNSHOD.
- 2) All mares will be wormed on arrival and charged to the Owner.
- 3) Mares whilst at this Stud will receive every possible care, attention and supervision, but no responsibility can be taken for accident, theft or disease. Stanley Grange Stud **strongly advises** that all animals should be **fully comprehensively insured** whilst at Stud.
- 4) Should veterinary assistance be deemed necessary by ourselves either in an emergency or to facilitate a pregnancy, the vet will be called and all costs will be paid by the mare owner direct to the veterinary surgeon, under their terms and conditions.
- 5) All mares will be SCANNED prior to leaving the Stud unless the mare owner specifies they do not require this service.
- 6) Stud Fees must be paid together with Keep and Grooms Fees on collection of the mare. Interest will be charged on all accounts, not settled within one month. Any concessions regarding stud fees will be INVALID if the account is not paid in full by 1st October in the year of service.
- 7) Service Certificates will be available on request once all accounts have been paid in full.
- 8) If the mare is not in foal, the Stud must be notified by 1st October in the year of service, or concessions on fees will be invalid.
- 9) Non-Thoroughbred/General Stud Book Covering Certificates. Please take special care of these as we are unable to supply duplicates.
